Criteria for appointment as dealer :

- 1) Period of contract will be for one year and may be terminated with one month's notice from either party.
- 2) Applications, complete in all respect, shall only be considered.
- 3) The applicant/organization must have electrical license from respective State Government(s).
- 4) The applicant/organization should preferably be a Graduate Engineer/have a Graduate Engineer as proprietor or Partner.
- 5) The applicant must have an office and employ technical persons/technicians having requisite experience.
- 6) The applicant must have valid Trade License, Income Tax PAN and Sales Tax, VAT, Service Tax registration.
- 7) The applicant must have full set of tools and tackles required for carrying out the business.
- 8) The applicant must declare its business activities of similar nature. In case if it is discontinued, appropriate reason for the same has to be furnished.
- 9) The applicant, if selected as dealer, has to pay in advance.
- 10) The applicant, if selected as dealer, has to deposit Rs.50000/- as interest-free Security Deposit which will be refunded at the time of termination.
- 11) BLL or its authorized representative reserves the right to inspect office/godown/site and the books of accounts of the dealer.
- 12) The Dealer selected, has to submit monthly stock statement of BLL items.
